# Privacy Policy

This Privacy Policy describes how and when we collect, use and share your information across our App. When using our App you consent to the collection, transfer, storage, disclosure, and use of your information as described in this Privacy Policy. You can be sure that we will only use your information as described in this Privacy Policy.

## I. How your information is used

### Registration and account information

When you create or reconfigure your account and use our App you voluntarily give us personal information, such as your name, email, phone number and, when necessary, billing information. If you provide us with your phone number, you agree to receive text messages to that number from us. You may choose to provide us with additional information, for example, with your permission, we may also access other personal information on your device, such as your phone book, calendar or messages. If authorized by you, we may also have an on-going access to your personal information from third-party social media sites like Facebook, if you and/or users of those sites give us access to such information, depending upon your or users' settings on those sites.

We may use information about you for various purposes, including to:

- provide, maintain and improve our services, including to provide additional features and content;
- respond to your questions and requests and provide customer service;
- send you technical notices, updates, security alerts and support, and administrative messages;
- monitor and analyze trends, usage and activities in connection with our services;
- personalize and improve the services;
- detect, investigate and/or prevent fraudulent, unauthorized or illegal activity; and
- carry out any other purpose for which the information was collected according to this

Privacy Policy.

Our systems are not designed to associate personal information with your activities (such as pages you view or things you click on or search for).

## **Location**

In serving you, we may use or store your precise geographic location, if you give us permission to do so. We may use and store information about your location to provide features of our App and to improve and customize the App. We do not use or share this data for any other purpose. Many devices will indicate through an icon when location services are operating. We only share this location information with others as approved by you.

## **Log data**

Our servers automatically record information ("log data") created by your use of the

App. Log data may include information such as your IP address, operating system, device and search terms. We receive log data when you sign into our App. We use

## **Limited period of personal data storage**

Our systems are designed to retain log data for up to 30 days after it is collected. We remove personally identifiable information (such as your name, address, email or phone number, location) and other preferences associated with your account promptly after you delete your account.

## **Restrictions towards children**

We do not knowingly contact or collect personal information from children under 13. If you become aware that your child has provided us with personal information without your consent, please contact us. If we become aware that a child under 13 has provided us with personal information, we take steps to remove such information and terminate the child's account.

## **No ad companies collect data through our service**

We do not allow advertising companies to collect data through our service for ad targeting.

## **II. When we disclose information**

### **Third-parties**

We provide personally identifiable information and non-personally-identifiable information only to our subsidiaries for the purpose of processing such information on our behalf. We require that these parties agree to process such information in compliance with our Privacy Policy, and we use reasonable efforts to limit their use of such information and to use other appropriate confidentiality and security measures.

### **Law and harm**

Notwithstanding anything to the contrary in this Privacy Policy, we may preserve or disclose your information if we believe that it is reasonably necessary to comply with a law, regulation, legal process, or governmental request; in order to investigate, prevent, or take action regarding suspected or actual illegal activities, including but not limited to, fraud, potential threats to public safety or the physical safety of any person; to protect the security or integrity of our products and services; or to protect rights, property, or our personal safety, our staff, our users or others. However, nothing in this Privacy Policy is intended to limit any legal defenses or objections that you may have to a third party's, including a government's, request to disclose your information.

### **Business transfers**

In the event that we are involved in a bankruptcy, merger, acquisition, reorganization or sale of assets, your information may be sold or transferred as part of that transaction. This Privacy Policy will apply to your information as transferred to the new entity. We may also disclose information about you to our corporate affiliates in order to help provide, understand, and improve our App and our affiliates' Apps.

### **Non-private or non-personal information**

We may share or disclose your non-personal information, such as your public user profile information, shared boards and so on. Remember: your privacy and visibility settings control whether your personal or any other information are made public.

You should take steps to protect against unauthorized access to your password, phone, and computer or mobile phone by, among other things, signing off after using a shared computer or mobile phone, choosing a password that nobody else knows or can easily guess, and keeping your password private. Also, you should never share your log-in information with others. We are not responsible for any lost, stolen, or compromised passwords or for any activity on your account via unauthorized password activity.

## **V. Changes to this Policy**

We may revise our Privacy Policy from time to time. If we make any material changes to our policies, we will place a prominent notice on our website or application. If we make a change to this Policy that, in our sole discretion, is material, we will notify you via the email address you optionally provided during sign up. By continuing to access or use the App after those changes become effective, you agree to be bound by the revised Privacy Policy.
